OTHERS, WHICH WERE PRODUCED FOR ALL VIRTUAL AUDIENCES AND DELIVERED VIA ZOOM, FEATURED REAL TIME Q&A TO ENCOURAGE ENGAGEMENT AND SCHOLARSHIP. THE SPEAKERS SELECTED WERE AUTHORS, RESEARCHERS, OR AUTHORITIES ON LITERARY OR BOOK-RELATED SUBJECTS AND REPRESENTED BOTH DIVERSITY OF TOPIC AND GEOGRAPHIC REGION.
