Sarah M. Pritchard: President

A Caxtonian since 2007, Sarah Pritchard is recently retired after 16 years as the Dean of Libraries and Charles Deering McCormick University Librarian at Northwestern University. In that role she led print and digital services for all the libraries on the Evanston campus, coordinated services with NU's libraries in Chicago and Qatar, and oversaw the award-winning Northwestern University Press. Previously she was the University Librarian at the University of California, Santa Barbara; Director of Libraries at Smith College; associate executive director at the Association of Research Libraries; and reference librarian and specialist in women's studies at the Library of Congress.

She has been involved with scholars, collectors and curators in special collections and archives in each of these institutions, and in her director positions she explicitly sought to extend the scope, content, funding and visibility of such collections. She has overseen grant funded projects for special collections supported by the NEH, IMLS, Mellon Foundation, Library of Congress and others. From 2009 to 2012 she served on the Special Collections Working Group of the Association of Research Libraries. She actively engaged with the fine press and book arts communities, especially in Western Massachusetts and Southern California.

She has held numerous offices in library professional associations and regional consortia, including 13 years on the governing Council of the American Library Association. She serves regularly on editorial boards and grant review panels and has been a speaker and consultant across the U.S. and internationally on library-related topics. She has published over 70 articles and reviews, and from 2009-2014 was the editor of portal: Libraries and the Academy (Johns Hopkins University Press). She was a founding director of the Chicago Collections Consortium and served on its Board for over 10 years, including three as the Chair.

Pritchard received her B.A. degree from the University of Maryland, and master's degrees in French and in Library Science from the University of Wisconsin-Madison. She is a member of Phi Beta Kappa and the Cosmos Club.
